- Individual Permit:** \$1500.00 Clean Water fee, General Permit information AND Completed General Information Form (GIF)
- PA DEP Fee:** \$100.00 per disturbed acre rounded to nearest whole acre

The Conservation District will review this plan solely to determine whether it is adequate to satisfy the requirements of PA Code Title 25, Chapter 102, *Erosion and Sediment Control*. By a determination that the plan is adequate to meet those requirements, neither the District nor Lebanon County assumes any responsibility for the implementation of the plan or the proper construction and operation of the facilities contained within the plan. The design, structure, integrity, and installation of the control measures are the responsibility of the landowner and/or operator. Before any earth disturbance may begin, the appropriate and necessary local, state, and federal permits must be secured from the agencies having specific permitting authority. For sites with proposed earth disturbance activities of 1.0 acre or greater, no earth disturbance may take place and no building permits shall be issued until the applicant receives a written letter of plan adequacy from the Lebanon County Conservation District.

## STATEMENT OF POLICY

1. All sites with 1.0 acre or greater of disturbance during the life of the project are required by law to comply with the National Pollutant Discharge Elimination System (NPDES) permitting guidelines.
2. Revised applications must be submitted for review to address identified technical deficiencies within 17 business days of the first technical review and 15 business days of the second technical review.
3. Permit decisions for new general NPDES stormwater construction permit applications will be made within 71 business days of the date the application is considered to be complete based on information available in the district file. Permit applications will be denied if there are continuing technical deficiencies and/or for which a demonstration cannot be made that applicable regulatory and statutory requirements have been met. If the applicant of a denied permit application wishes to continue to pursue approval of the project, the applicant must submit a new application with all corresponding fees and documentation.
4. The District reserves the right to modify fees on a case-by-case basis.

## NPDES PERMITTING PROCESS FOR CONSTRUCTION SITES DISTURBING 1.0 ACRE OR GREATER

<b>GENERAL NPDES PERMIT</b> (\$500.00 clean water fee)	<ol style="list-style-type: none"> <li>1. The project disturbs 1 or more acres in a watershed not protected by High Quality (HQ) or Exceptional Value (EV) status</li> </ol>
<b>INDIVIDUAL NPDES PERMIT</b> (\$1500.00 clean water fee)	<ol style="list-style-type: none"> <li>1. The project is in a special protection HQ or EV watershed</li> <li>2. The construction activities discharge toxins</li> <li>3. The construction activities will violate water quality standards</li> <li>4. The construction activities are in areas inhabited by Federal or State Endangered Species</li> </ol>

**GENERAL PERMIT:** The District reviews the E&S plan for adequacy. Once adequate, the District issues approval for permit use.  
**INDIVIDUAL PERMIT:** The District reviews the E&S plan and additional Best Management Practice considerations for water quality protection in HQ or EV watersheds. After District review is complete, recommendation for permit action is sent to the DEP's South Central regional office for final processing. Before a permit is issued, an application must be published in the PA Bulletin for public review.
